Pinecrest Gardens hereby requests approval to proceed with a single source vendor proposal for the fabrication and installation of interpretive signs in the Lower and Middle Gardens.

The recommended vendor previously produced and installed the existing interpretive signage in the Upper Gardens. Utilizing the same company will ensure continuity in design, materials, fabrication methods, and construction standards, preserving aesthetic and structural consistency throughout the Gardens and maintaining a cohesive visitor experience.

This project is already budgeted and supported by matching grant funding. Maintaining alignment with the established signage system avoids discrepancies in materials, mounting systems, and graphic standards, while leveraging the vendor's familiarity with site conditions and specifications. For these reasons, staff recommends approval to proceed with the proposed single source vendor at this time.
