The vendor previously installed the existing fence, and utilizing the same company will ensure continuity in design, materials, and construction standards. This consistency is critical not only for aesthetic and structural uniformity but also for the safety of the animals, some of whom have begun attempting to jump the current fence height.

Given the urgency of the situation and the need for seamless integration with the current structure, we believe using the original vendor is the most efficient and secure solution. The costs for this project will be funded through existing Parks Impact Fees.
