NOW, THEREFORE, this Agreement witnesseth that for and in consideration of the mutual benefits to flow each to the other, the parties agree to a renewal of said original Agreement for a period beginning the 20 day of July, 2024 and ending the 19 day of July, 2025 at a cost of \$7,876.00.

All terms and conditions of said original Agreement shall remain in force and effect for this renewal.

RE: Resolution Authorizing the Village Manager to Execute an Agreement with the Florida Department of Transportation (FDOT) for the Landscape Maintenance of Pinecrest Parkway (US 1)

Every year, the Village enters into an agreement for Turf and Landscape Maintenance with the Florida Department of Transportation (FDOT) for the maintenance of all landscape and turf areas along the median on Pinecrest Parkway (US 1). FDOT has requested a contract renewal for one year beginning July 20, 2024. This renewal reimburses the Village \$7,876.00, which covers the cost for the Village's landscape contractor to provide the service.

I hereby respectfully recommend that the Village Council adopt the attached resolution which authorizes the Village Manager to execute the agreement with FDOT.
