I. CALL TO ORDER/ROLL CALL OF MEMBERS: The meeting was called to order by the mayor at 5:00 p.m. Present were the following:

Councilmember Fairman made a motion to allow Councilmember Meyer to participate virtually. The motion was seconded by Councilmember del Prado and adopted by a unanimous voice vote. The vote was as follows: Councilmembers del Prado, Fairman, Meyer, Vice Mayor Greenberg, and Mayor Corradino voting Yes.

The motion was seconded by Councilmember Fairman and adopted by a voice call vote as follows: Councilmembers del Prado, Fairman, Meyer, Vice Mayor Greenberg, and Mayor Corradino voting Yes.

The Council presented a proclamation to Miami Palmetto Senior High School for their outstanding contributions to the community through blood donation efforts in partnership with OneBlood and Chick-fil-A. Pinecrest resident Mindy Dickman presented to the Council regarding traffic issues and concerns on SW 122 Street, particularly during school hours, and suggested installing speed bumps. The Village Manager confirmed that a comprehensive traffic study of the school area is underway at the Council's request.

Vice Mayor Greenberg introduced Porch Pinecrest, a local group that works to combat hunger by supporting local children and families. Maryann Rio, representing Porch Pinecrest, provided an overview of their efforts with the Council and community. Under
