5. Howard Palmetto Baseball and Softball Association

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF THE VILLAGE OF PINECREST, FLORIDA, AS FOLLOWS:

Section 1. That the Village Manager is hereby authorized to enter into agreements with Miami Premier Soccer Club, Soccer Shots Miami, Suniland Sundevils Sports Group Inc., Pinecrest Premier Soccer Club, and Howard Palmetto Baseball and Softball Association for *Priority Athletic Field Use*.
