WHEREAS, the Village issued an Invitation to Bid for the "*Sidewalk Flags Replacement 2nd Phase*" project; and

WHEREAS, sealed proposals were received by the published deadline; and

WHEREAS, SC Contractors submitted the most responsive proposal;

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF PINECREST, FLORIDA,
AS FOLLOWS:

Section 1. That the Village Council hereby determines that SC Contractors has submitted the most responsive bid and hereby authorizes the Village Manager to enter into an agreement with said firm for the furnishing of all labor, materials, tools, equipment, machinery, superintendence, and services necessary for the completion of the project as detailed in the *Sidewalk Flags Replacement 2nd Phase Project* Invitation to Bid packet in an amount not to exceed \$66,446.00.

Section 2. This resolution shall take effect immediately upon adoption.

The project includes demolition, removal and disposal of existing sidewalk, form, placement, and finish of new sidewalk. As a result of the ITB, the following nine (9) bids were received by the march 13, 2025, deadline:
