RE: Resolution Authorizing Roadway Resurfacing Moss Ranch Road from east of SW 64th Street to SW 62nd Street

Attached for your consideration is a resolution authorizing the Village Manager to enter into a contract with Metro Express for roadway resurfacing of Moss Ranch Road from east of SW 64 Street to SW 62nd Street in the amount of \$88,816. The construction proposal is based on pricing provided in a piggy-back contract that was approved by the Village Council via Resolution 2023-8. Funding for this project is allocated in the FY 2024 Budget, Transportation Fund as miscellaneous roadway resurfacing.

I hereby respectfully recommend the Village Council adopt the attached resolution authorizing the Village Manager to accept the proposal and enter into a contract for the aforementioned roadway work.
