The Village published a Request for Qualifications (RFQ) for the Gary Matzner Park Conceptual Design, which will provide professional services the conceptual design as detailed in the Master Plan approved by Village Council.

As a result of the RFQ, six (6) proposals were received by the May 20, 2022 deadline:

- MKSK
- SMDS
- LDE
- WEST A+D
- URBAN ROBOT ASSOCIATES
- CHISHOLM

A staff committee evaluated the proposals based on the firms' experience and capability, project team and staffing, work plan, references, and completeness of the proposal. Based on these criteria, the committee selected MKSK Inc.

I hereby respectfully recommend the Village Council adopt the attached resolution authorizing the Village Manager to negotiate a professional services agreement with MKSK Inc. for the Gary Matzner Park Conceptual Design.
