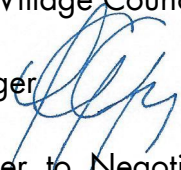

RE: Resolution Authorizing the Village Manager to Negotiate a Professional Services Agreement for the Pinecrest Gardens Farmers Market Management and Operation Services

The Village published a Request for Proposals (RFP) for Pinecrest Gardens Farmers Market Management and Operation Services.

As a result of the RFP, four (4) proposals were received by the June 18, 2026, deadline:

- The Market Company
- Miami Culinary Kitchen
- Nationwide Health Network
- Florida Fresh Markets

A committee evaluated the proposals based on the firm's experience and capability, project team and staffing, pricing, work plan, references, and completeness of the proposal. Based on these criteria, the committee selected Miami Culinary Kitchen.

I hereby respectfully recommend the Village Council adopt the attached resolution authorizing the Village Manager to negotiate a professional services agreement with Miami Culinary Kitchen for the Pinecrest Gardens Farmers Market Management and Operation Services.
