RE: Permit Fee Assessment

Attached for your consideration is a copy of a proposal from JRD & Associates, Inc. (JRD), to examine and reassess the Village of Pinecrest building, zoning, and planning permit fees. Florida Statute 553.80 require that permit fees be set at an amount that strictly cover the cost of provident permit-related services. It specifically states: "The governing bodies of local governments may provide a schedule of fees, as authorized by s. 125.56(2) or s. 166.222 and this section, for the enforcement of the provisions of this part. Such fees shall be used solely for carrying out the local government's responsibilities in enforcing the Florida Building Code. The last permit fee review was conducted nearly 8 years ago in October 2011.

The proposed review will identify and recommend changes, additions and deletions to the existing fee schedule to accurately reflect the actual costs associated of providing the feerelated services and ensure the Village's compliance with the applicable state statutes.

I respectfully recommend that the Village Council approve the attached resolution authorizing the Village Manager to execute the agreement for the aforementioned services.
