WHEREAS, the Village issued an Invitation to Bid for the "Suniland Park Perimeter Fencing" project; and

WHEREAS, sealed proposals were received by the published deadline; and

WHEREAS, Cunano Builders Corporation submitted the most responsive proposal;

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF PINECREST, FLORIDA, AS FOLLOWS:

Section 1. That the Village Council hereby determines that Cunano Builders Corporation has submitted the most responsive bid and hereby authorizes the Village Manager to enter into an agreement with said firm for the furnishing of all labor, materials, tools, equipment, machinery, superintendence, and services necessary for the completion of the project as detailed in the Suniland Park Perimeter Fencing Invitation to Bid packet in an amount not to exceed \$222,300.00.

Section 2. This resolution shall take effect immediately upon adoption.

RE: Resolution Awarding Suniland Park Perimeter Fencing

The Village published an Invitation to Bid (ITB) for the Suniland Park Perimeter Fencing, part of the 2019 Capital Improvement Bond, budgeted for \$225,000.00. This project consists of replacing 2,700 SF of the perimeter fence, with two options to install a Dog Park Picket or Chain-Link fence at Suniland Park. As a result of the ITB, the following three bids were received by the May 30, 2019 deadline:

CUNANO BUILDERS CORPORATION	\$164,150.00
Option A – Picket Fence	\$58,150.00
Option B – Chain-Link Fence	\$39,850.00
TECHGROUPONE, INC	\$185,526.49
Option A – Picket Fence	\$69,808.21
Option B – Chain-Link Fence	\$34,699.37
CUSTOM CONCEPTS MIAMI INC	\$278,259.92
Option A – Picket Fence	Included
Option B – Chain-Link Fence	N/A

Based upon staff's evaluation of the proposals, I hereby respectfully recommend that the Village Council adopt the attached resolution awarding the contract for the Suniland Park Perimeter Fence, with Option "A" - Dog Park Picket Fence, to the lowest Bidder, CUNANO BUILDERS CORPORATION in the amount of \$222,300.00.
