RE: Resolution Authorizing the Village Manager to Enter into a Professional Services Agreement with The Beta Jones Group for the Pinecrest Gardens ADA Compliant Pathway Design

The Village published a Request for Qualifications (RFQ) for the Pinecrest Gardens ADA Compliant Pathway Design, which will provide plans and specifications as required by ADA for full compliance with part II and III of the American with Disability Act. As a result of the RFQ, five proposals were received by the deadline.

At the June 11, 2019 meeting, the Village Council authorized the Village Manager to negotiate a professional services agreement with the selected firm, The Beta Jones Group. After a successful negotiation, The Beta Jones Group has agreed to perform the Pinecrest Gardens ADA Compliant Pathway Design for the total amount of \$160,000.

I hereby respectfully recommend the Village Council adopt the attached resolution authorizing the Village Manager to enter into a professional services agreement with The Beta Jones Group for the Pinecrest Gardens ADA Compliant Pathway Design.
