WHEREAS, M & J Consulting Group submitted the most responsive proposal;

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF PINECREST, FLORIDA,
AS FOLLOWS:

Section 1. That the Village Council hereby determines that M & J Consulting Group has submitted the most responsive bid and hereby authorizes the Village Manager to enter into an agreement with said firm for the furnishing of all labor, materials, tools, equipment, machinery, superintendence, and services necessary for the completion of the project as detailed in the *Municipal Center First Floor Lobby Repurpose* project Invitation to Bid packet in an amount not to exceed \$226,411.00.

Section 2. This resolution shall take effect immediately upon adoption.

RE: Resolution Awarding Municipal Center First Floor Lobby Repurpose

The Village published an Invitation to Bid (ITB) for the Municipal Center First Floor Lobby Repurpose to enhance building security. This project consists of removing the existing door, header, ceiling lights, tile and brick floors and the installation of new front-store type of glass, floors, as well as, mechanical and electrical work at the Pinecrest Municipal Center, 12645 Pinecrest Parkway. As a result of the ITB, the following two (2) bids were received by the September 30, 2019 deadline:

Green Engineering and Construction, Inc.	\$247,664.00
M&J Consulting Group	\$226,411.00

Based upon staff's evaluation of the proposals, I hereby respectfully recommend that the Village Council adopt the attached resolution awarding the contract for the Municipal Center Building First Floor Lobby Repurpose project to the lowest Bidder, M&J CONSULTING GROUP, in the amount of \$226,411.00.
