WHEREAS, the Village issued an Invitation to Bid for the "Pinecrest Entrance Monument Signs" project; and

WHEREAS, sealed proposals were received by the published deadline; and

WHEREAS, Sun Eagle General Contractors, Corp. submitted the most responsive proposal;

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF PINECREST, FLORIDA, AS FOLLOWS:

<u>Section 1</u>. That the Village Council hereby determines that Sun Eagle General Contractors, Corp. has submitted the most responsive bid and hereby authorizes the Village Manager to enter into an agreement with said firm for the furnishing of all labor, materials, tools, equipment, machinery, superintendence, and services necessary for the completion of the project as detailed in the *Pinecrest Entrance Monument Signs* project Invitation to Bid packet in an amount not to exceed \$120,000.00.

<u>Section 2</u>. This resolution shall take effect immediately upon adoption.

RE: Resolution Awarding Pinecrest Entrance Monument Signs Bid

The Village published an Invitation to Bid (ITB) for the Village of Pinecrest Entrance Monument Signs. The project includes fabrication and installation of six (6) monument signs, including landscape, wiring for lighting and electrical connections. As a result of the ITB, the following five (5) bids were received by the December 20, 2019 deadline:

Based upon staff's evaluation of the proposals, I hereby respectfully recommend that the Village Council adopt the attached resolution awarding the contract for the Village of Pinecrest Entrance Monument Signs to the lowest bidder, SUN EAGLE GENERAL CONTRACTORS, CORP in the amount of \$120,000.00. This project was budgeted at \$100,000.00 as part of the 2019 Bond Issuance and therefore a budget amendment submitted to cover the \$20,000.00 balance.
